Saantec Yamakawa and Kansai Saan Gas to Merge

Two of Taiyo Nippon Sanso's consolidated subsidiaries – Saantec Yamakawa Co., Ltd. and Kansai Saan Gas Co., Ltd. – will merge on January 1, 2008.

Saantee Yamakawa is a wholesaler which sells welding equipment and industrial gases mainly in Western Japan, while Kansai Saan Gas is an industrial gas trading company that is renowned for its technical expertise in gas supply, and they operate in the Kinki region.

The new company will become the core trading company in the TNSC Group's operations in Western Japan. It will leverage the combined welding equipment wholesale know-how and technical enterprise in the industrial gases field, to expand the Group's business in that part of Japan.

Below, is a brief description of the new company to be formed from the merger, whose name has yet to be decided, as well as the two parties at current state.
